INSTRUCTIONS FOR PREPARING SMALL CLAIMS COMPLAINTS

1. Prepare document entirely. (NOTE: Affidavit must be filed out by a Notary Public)
2. Amount claimed in small claim cases may not exceed \$10,000.00, exclusive of interest and costs.
3. State nature of claim, giving dates and other relevant data. If the claim is based on written contract or other instrument, the contract or other instrument must be attached to the small claim complaint original and all copies of the complaint. In cases of accounts, the bill sued for (copy) must be attached.
4. Filing fees for complaint of:

\$250.00 to under is	\$83.00
\$250.01 to \$500.00 is	\$93.00
\$500.01 to \$2,500.00 is	\$113.00
\$2,500.01 to \$10,000.00 is	\$148.00
5. Service of summons is by the Sheriff or Civil process server. You must make arrangements with that office.
6. Certified mail summons are \$16.50 which includes postage.
7. The resident to be sued with service by certified mail must reside in Stephenson County. Residents out of the county may be sued in this county, but will need service of summons by the Sheriff or process server in the county in which he/she resides.
8. Jury demand fee is \$212.50
9. A person has the right to handle his/her own case without the assistance of an attorney. However, if complications arise, you may wish to consult an attorney.
10. The first appearance in court will be the trial date, unless it is a contested matter. A trial will be set at that time. Nevertheless, the plaintiff should bring along any documents to support his/her claim. It is not necessary to bring along witnesses at this time.
11. It is important to be in court promptly at the time set for your trial and to be ready for trial. If you have evidence to support your case, it too should be available.
12. Continuances will be granted only by the Judge to which the case is assigned.
13. If a judgment is entered in your favor and is not promptly paid, it is recommended that an attorney be consulted. The remedies available for collection are generally too complicated to be exercised without legal advice.
14. The foregoing instructions are not intended to explain all the rights and duties of small claim litigation, but are for your guidance. For additional information, consult an attorney.
15. The Circuit Clerk's Office is not a collection agency and **will not** accept payments on judgments.
